O R D E R

1. IA No.58933/2025 (application for intervention) is allowed.
2. Pleadings in Army matters are complete and written submissions have also been filed by the Union of India.
3. Post these matters along with 'Navy' (Diary No.53802/2024 and connected matters), 'Air Force' (Diary No.21469/2023 and 28412/2024 and connected matters) and 'Coast Guard' matters (Diary No.4518/2024 and connected matters) for final hearing on 06.08.2025 and 07.08.2025 at 11:00 a.m. The Army matters will be taken up first, and after conclusion of hearing in those matters, Navy, Air Force and Coast Guard matters shall be taken up in this sequence.
4. Without prejudice to the rights of both sides and without creating any equity in favour of the officers, it is directed that

all the officers who are presently in service, including Lt. Col. Geeta Sharma (applicant in IA No.55208/2025), shall not be relieved and be allowed to continue till the next date(s) of hearing.
