ORDER

- 1. Leave granted.
- 2. Heard learned counsel for the parties.
- 3. This appeal arises from an order dated 15.05.2025 passed by the High Court of Judicature at Patna rejecting the bail prayer of the appellant in connection with FIR No. 641/2024.
- The submission of the learned Counsel for the 4. is that the offences for which appellant the appellant is arraigned as an accused all are Magistrate triable offences, investigation respect of which is complete qua the appellant who has previous criminal antecedents no and,

therefore, there is no justification to keep the appellant in jail pending trial.

- 5. The learned counsel for the respondent has opposed the prayer for bail by submitting that appellant is a beneficiary of the sale which has been executed through an impostor and, therefore, it is not a fit case where he should be given benefit of bail.
- the of the 6. Having regard to nature allegations as also that appellant is stated to be a witness to one of the executing parties which may be his own mother and taking into account that the offences are Magistrate triable and the trial is not likely to conclude in near future, while taking into account that appellant has suffered incarceration since 16.02.2025, without expressing any opinion on the merits of the prosecution case, we are of the view that the appellant is entitled to be released on bail.
- 7. The appeal is accordingly allowed. The order passed by the High Court rejecting the bail prayer of the appellant is set aside.
- 8. The appellant shall be released on bail on such terms and conditions as the trial court may

deem fit to impose in the facts and circumstances of the case.

9. Pending application(s), if any, shall stand disposed of.
